ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.315 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.315 per Offer Share, the net proceeds from the Global Offering to be received by the Company, and after deducting the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$82.4 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Applications Under the Hong Kong Public Offer

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offer have been significantly over-subscribed. A total of 11,504 valid applications have been received pursuant to the Hong Kong Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 10,146,384,000 Hong Kong Offer Shares, equivalent to approximately 289 times of the total number of 35,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offer. The final number of the Hong Kong Offer Shares is 175,000,000 Offer Shares, representing 50% of the total number of the Offer Shares available under the Global Offering.

International Placing

- The Offer Shares initially offered under the International Placing have been moderately over-subscribed. The final number of the Offer Shares allocated to 137 places under the International Placing is 175,000,000 Offer Shares after reallocation to the Hong Kong Public Offer, representing 50% of the total number of the Offer Shares initially available under the Global Offering. A total of 70 places have been allotted three board lots Shares or less, representing approximately 51.09% of total number places under the International Placing. A total of 56 places have been allotted one board lot Shares, representing approximately 40.88% of total number places under the International Placing.

- The Directors confirm that no Offer Shares have been allocated to applicants who are connected persons, directors or existing shareholders of the Company or their respective close associates within the meaning of the Listing Rules. The Directors confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.
